Good morning Darren,

The Brockton Heritage Committee are still deciding on the design and construction of the historic plaques, and wondered if you would be to provide an updated quote in comparison to the November/December 2020 quote if they were to proceed with the first design of the aluminum plaque?

However, they also would like to obtain a quote for a pedestalled plaque which would be more design focused with coloured photos and a text description. The plaque would be approximately 24" x 30" and 2" thick, and would also require a full pedestal for mounting. They have also considered a high pressure laminate plaque that would be ½" thick and mounted to a 4" x 4" lumber post. I have attached a photo of similar plaque designs for reference. Is this something that Holm Graphics can

create?

I have also attached draft wording for the plaques in case that assists you with the original aluminum plaque. I assume that if the Committee chose the coloured design plaque, the wording would have to be adjusted or shortened.

If you could please send me both these quotes by June 1, 2021 I would appreciate it as the Committee is holding a meeting on June 7th and I would like to include the quotes on that agenda.
