Good afternoon everyone,

I am passing along information from Miller Plaques in the email below, as well as the attachments for reference regarding the construction, design, and costs for the plaques completed with the Town of Saugeen Shores.

If you would like to review the information, and think up the type of photos/design you would prefer on the heritage plaques for the Truax Dam and Bridge 11 before the June 7th Committee Meeting that would be great.

I will also reach out to Holm Graphics and Cox Signs to obtain new quotations from them regarding this new type of plaque design, since the original quotes from November 2020 were created with the 2015 Centretown Condos plaque design in mind.

It is my understanding from speaking with Mr. Miller, that the design would be created from a separate graphic designer, and if Miller Graphics were approved for the project, they would work with the designer to ensure the design fits with the construction of the plaques. If a local company were contracted to construct the plaques, I would assume we would still require a design to be completed for the plaques and there would likely be collaboration as well.

The Committee would also need to approve final wording for the plaques, whether the Saugeen Shores design, or 2015 Centretown Condos plaque design were chosen. I know that the wording was discussed, but I don't believe it was fully approved at the last meeting. The approximate word count is around 125-140 words in compared to the 2015 Centretown Condos plaque. The word count may be required to be altered if a new design were chosen.

I will include all of this information in the June 7th Committee Agenda Package, but wanted to pass along the information ahead of time so you were updated on the status of the project.

Hi Sarah,

Sorry for the delay but I have finally got some information for you.

The plaques that we do for Saugeen Shores are typically modular panels with pedestals. These are normally 24" x 30" x 2" thick. and come with a full pedestal and tamper proof hardware. The current price for these is \$1050.00 + shipping and HST (roughly \$1400.00 including paper proofs). I recommend this type of plaque if it is going to be placed in a "formal" setting such as in a downtown park, municipal building, Victoria Hall etc. If the plaque is going to be placed along a hiking trail or similar environment you might want to consider a different style of plaque like Armollte mounted to a pressure treated 4" x 4" lumber post. These plaques are a high pressure laminate and are typically 1/2" thick and are mounted to the post with a post bracket (photos attached). I can't give you exact pricing today because I just spoke to my supplier and they are reviewing pricing. I have asked for some current prices and will let you know as soon as I hear from them. (Hopefully later this week.)

Hopefully this information will he helpful.
