Municipality of Brockton's Updated Response to COVID-19

Brockton, ON, May 19, 2021 - The Municipality of Brockton's original State of Emergency due to the COVID-19 pandemic remains in effect. The Province of Ontario further extended both the Stay-at-Home Order and Declaration of Emergency until at least June 2, 2021 due to the continued risks associated with COVID-19 variants. All public health and workplace safety measures under the provincewide emergency brake also remain in effect. Visit the Provincial Website to learn more about the restrictions in effect. The Province is urging people to stay home and not travel outside the region they reside in.

Municipal Impacts:

The Municipality of Brockton continues to prioritize the health and well-being of residents and businesses by following advice from the Grey Bruce Health Unit and Provincial Government. The following Municipality of Brockton facilities and operations are impacted in the following ways, in order to comply with regulations and more importantly, help reduce the spread of the COVID-19 Virus.

Parks and Recreation Facilities and Amenities that Remain Closed:

Under the Stay-at-Home Order, the following outdoor recreational amenities remain closed until further notice:

- Sports fields
- Baseball diamonds

- Basketball and tennis courts
- Picnic areas, park shelters and facilities

The Recreation Office at the Walkerton Community Centre remains closed to the public until further notice, with the exception of drop-offs for well water samples. Well-water samples can be dropped off at the Walkerton Community Centre between the hours of 8:30-1:40 p.m. Monday to Friday. Recreation Department inquires can still be made by telephone 519-881-0625 or email.

All facility rentals, recreational and leisure programs, including private bookings have been postponed until further notice. The Elmwood Community Centre, Cargill and District Community Centre and Bradley School House Community Centre are closed to the public until further notice.

Parks and Recreation Facilities and Amenities that Remain Open:

- Playground structures at all parks
- Boat launches and fishing from Lobies Park and/or Saugeen River
- Greenspaces and trails for walkthrough access

Note: Any person who uses any of the amenities that have remained open, shall maintain a physical distance of at least two metres from any other person who is also using the amenity, other than a person who is a member of the same household, a member of one other household who lives alone or a caregiver for any member of either household.

Municipal Buildings that Remain Closed to the Public:

The following Municipal facilities remain closed to the public until further notice:

- Municipal Office
- Greenock Landfill
- Walkerton Community Centre (Exception of Well Water Samples)

- Bradley School House
- Cargill Community Centre
- Elmwood Community Centre
- Walkerton and Elmwood Fire Halls
