The Corporation of the Municipality of Brockton



By-Law 2021-086

Being a By-Law to Amend By-Law 2020-103 to Establish, Ratify and Impose Fees and Charges for Goods and Services Provided By the Municipality of Brockton.

Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 391(1) authorizes a municipality to impose fees or charges on any class of persons,

- a) for services or activities provided or done by or on behalf of it;
- for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and
- c) for the use of its property including property under its control.

And Whereas Municipal Councils have the authority to establish rates and fees under various Acts, and the Council of the Corporation of the Municipality of Brockton deems it expedient to pass a by-law establishing certain fees and charges;

And Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 398 (2) authorizes the treasurer of a local municipality to add fees and charges imposed by the municipality or local board, to the tax roll for the real property for which the owner or owners are responsible for paying the fees and charges;

And Whereas the Municipality of Brockton enacted By-Law 2020-103 on September 22, 2020 establishing, ratifying, and imposing fees and charges for goods and services provided by the Municipality of Brockton;

And Whereas the Municipality of Brockton deems it expedient to amend By-Law 2020-103;

Now Therefore the Council of The Corporation of the Municipality of Brockton enacts as follows;

- 1.0 That The Corporation of the Municipality of Brockton Council hereby amend Schedule "A" of By-Law 2020-103 2021 Fees and Charges By-Law attached hereto and forming an integral part of this By-Law to include amended rates and fees for refreshment vehicles.
- 2.0 That the revised refreshment vehicle rates and fees as set out in Schedule "A" come into effect June 23, 2021.
- 3.0 This By-Law shall come into full force and effect upon final passage.
- 4.0 That By-Law 2020-103 be hereby amended.
- 5.0 This By-Law may be cited as the "Amend 2021 Fees and Charges By-Law".
