

Importance

Some criteria for evaluating importance / effectiveness of potential strategic initiatives

- Very effective way to accomplish broad goals
- Mandatory for municipalities
- High community support / concern
- Liability avoided
- ROI opportunity
- Public health and safety
- Organizational effectiveness



Feasibility

Some criteria for evaluating feasibility of potential strategic initiatives

- Cost
- Available funds
- Jurisdiction
- Technical issues
- Regulatory or other approvals
- Leadership and staff time
- Government partners and allies
- Community partners



Feasibility Assessment

- Cost operating (order of magnitude)
- Cost capital (order of magnitude)
- Non-tax revenue available or payback period
- Staff time implications
- Jurisdiction, engineering, regulatory issues
- Timeliness potential external opportunities
- Untimeliness potential external obstacles



Conditionality

Some conditions that could determine: whether, when, how

- Can only do if ...
- Cannot do if ...
- Can only do after ...
- Can only do before ...
- Must do in partnership with ...
- Will respond if ...



Timing

Factors that affect when an initiative can be started or completed (e.g. 2021-22, 2023-24, 2025 or beyond)

- Importance / community expectation
- Work or prep underway / ongoing
- Statutory sequence
- Logical sequence
- Priorities of potential partners



Your Action Priorities Can Be Expressed By:

- Timing
 - 2021-2022 (short term)
 - 2023-2024 (medium term)
 - 2025 and beyond (long term)
- Conditions
 - Provided that X takes place
 - Unless X takes place
- The verbs you choose



The Verbs You Choose Describe Your Intent For The 2021-2025 Period

- Direct municipal control
 - Build, establish, regulate, convene, etc
- Sequential or preparatory
 - Study, plan, etc
- Not your direct control initiative
 - Advocate, encourage, partner with, fund, etc
- Not your direct control reaction
 - Recognize, monitor, welcome, etc
- Tricky statements to watch for:
 - Support how / how much? Reactive only?
 - Study study whether to? Study how / when to?



Commitment To Action – Specific and Clear

- Actions meaningful, clear, feasible
- Actions with demonstrable results: 'difference makers'
- Subject to what conditions / prerequisites?
- Target time to start and / or finish?
 - By whom, with what support?
 - How will we measure success?
