By-Law 2021-125

Being a By-Law to Authorize the Signing of a Memorandum of Understanding Between the Corporation of the Municipality of Brockton and the Chepstow and District Lions' Club for the Purpose of Providing Services for Decorative LED Lights in the Village of Chepstow

Whereas The Council for the Corporation of the Municipality of Brockton deems it expedient to enter into an Memorandum of Understanding with the Chepstow and District Lions' Club for the purpose of providing services for 20 decorative LED lights to be installed year-round on the main street in the village of Chepstow;

And Whereas the parties require access to facilities owned by the other to accomplish this goal;

And Whereas the Corporation of the Municipality of Brockton and the Chepstow and District Lions' Club wish to enter in to an agreement outlining the responsibilities of each party as outlined in Schedule "A" attached hereto.

Now Therefore the Council of the Corporation of the Municipality of Brockton enacts as follows;

- 1.0 That the Corporation of the Municipality of Brockton enters into a Memorandum of Understanding with the Chepstow and District Lions' Club as outlined in "Schedule A" attached hereto and forming part of this By-Law;
- 2.0 That the Mayor and Clerk are hereby authorized on behalf of the Corporation of the Municipality of Brockton to sign the Memorandum of Understanding as well as any other related documents.
- 3.0 This By-Law shall come into full force and effect upon final passage.
- 4.0 This By-Law may be cited as the "Chepstow Lions Club Streetlight Memorandum of Understanding By-Law".

The Corporation of the Municipality of Brockton (hereinafter referred to as the Corporation)

And

The Chepstow & District Lions' Club (hereinafter referred to as "Chepstow Lions Club")

Term of Agreement

The term of this Memorandum of Understanding (MOU) shall commence the day	of
, 2021 and shall be completed on the last day of	, 202_

The Corporation and Chepstow Lions Club are entering into this MOU for the purpose of providing services for 20 decorative LED lights to be installed year-round on the main street in the village of Chepstow.

Responsibilities:

It is hereby acknowledged that the parties hereto agree as follows:

1. The Corporation shall

- a) Contact Hydro One to obtain permission and permits to install the new LED Decorative Lights.
- b) Be responsible for the additional electricity costs associated with the new lights.
- c) Be responsible for 50% of the costs associated with future maintenance and repair/replacement of the new LED decorative light fixtures.

2. The Chepstow Lions' Club shall

- a) Provide the Corporation with details of the LED decorative lights to be installed including being the project lead.
- b) Manage/ organize the installation of the new LED decorative lights.
- c) Provide the Corporation with proof of insurance and WSIB certificates for the contractor that will be doing the installation and maintenance of the LED streetlights.
- d) Be responsible for 50% of the cost for future maintenance and/or replacement of the LED streetlights.
- e) Contact the Corporation to report any outages, or maintenance issues.

3. The Corporation and the Chepstow Lions' Club shall

- a) Determine the approximate financing required to be included in the Corporation's streetlights budgets for the electricity and future maintenance as required.
- b) Appoint a Project Lead for the installation and maintenance of the new LED decorative lights.
- c) Monitor the performance of the new LED decorative lights, including associated electricity and maintenance costs.
- d) Review this agreement annually to ensure both parties are familiar with their responsibilities.

Schedule "A" to By-Law 2021-125

This agreement shall be binding on the Chepstow & District Lions' Club and the Corporation of the Municipality of Brockton, their successors, administrators and assigns.
