Background:

In accordance with the Municipality of Brockton's Procedural By-Law, staff have compiled a draft calendar of the 2022 Council Meeting dates.

Analysis:

Council Meetings

The meetings have been scheduled for the second and fourth Tuesdays of each month at 7:00 p.m., unless specified. The two meetings in June 2022 were rescheduled to the first Tuesday, June 7th and third Tuesday, June 21st to accommodate the AMCTO Conference.

Staff propose that Council Meetings continue to be broadcast through eSCRIBE, occurring as hybrid meetings to allow for a mix of in-person and electronic participation to continue to accommodate the COVID-19 pandemic restrictions.

Staff are recommending that Council approve the attached 2022 Council Meeting Schedule.

2022 Budget Meetings

Three (3) meetings on Tuesday, January 18, 2022, Wednesday, January 19, 2022, and Tuesday, February 8, 2022 have been scheduled as Budget Meetings to consider the 2022 Municipal Budget. Staff are proposing that the Budget Meetings begin at 9:00 a.m. in January, and at 1:00 p.m. on Tuesday, February 8, 2022 and continue into the regular Council Meeting at 7:00 p.m. on Tuesday, February 8, 2022. The Budget Meetings will be tentatively scheduled to occur in person with social distancing and screening protocols in place.
