### **Background:**

The following report summarizes operational data, maintenance activities, and compliance issues identified during the Operating Month of August 2021.

#### **Analysis:**

There were no compliance or regulatory issues in relation to the operations and/or maintenance of the Lake Rosalind water system or the Walkerton Water and Wastewater systems for the month of August 2021.

On August 11, at the Chepstow Water System, the Ultraviolet Light (UV) System failed to restart properly after a power outage. This caused the well to run without UV disinfection for approximately 4 minutes. Chlorine disinfection was active and working during the event. Water was treated effectively. The UV system was restarted by Veolia Staff. The Ministry of Environment, Conservation, and Parks (MOECP) and the Grey Bruce Health Unit were immediately notified as per our regulatory and internal Drinking Water Quality Management System protocols. It was determined that the UV lockout was not working and malfunctioned due to the power outage. The new UV lockout system was replaced and tested. There were no concerns or actions raised by the MOECP or the Health Unit, aside from the requirement to replace the UV Lockout System.
