# 4. Project Review

- Trusses are on site and framing is scheduled to start within next few days.
- P. Toews reviewed Change Order #1 for proposed work on catch basins, the exterior south cement slab and asphalt removal. The total of the changes would be \$13,720.00 plus HST. The items need to be carried out to address water issues especially from spring snow melt. Dawley Engineering strongly recommend the implementation change order items and stated costs were reasonable. Committee approved proceeding with Change Order. J. Morgan (for the Municipality of Brockton signed the Order and P. Toews will arrange for Domm Construction to sign.
- Going forward, the Committee appointed J. Morgan and M. Weber to oversee construction concerns and further change orders.
- J. Morgan suggested looking at any other drainage problems in the park next spring.
- G. Lippert provided B. Reinhart, Domm Construction, had informed they are working with Cuneo Interiors on three colour options to present to the Committee at a later date.
