7.1 Speaker Series

Zero Waste Workshop – Tuesday, October 16, 2018

C. Reich reported 27 people attended the Zero Waste Workshop on Tuesday October 16, 2018. The Walkerton Rotary Club and Girl Guides have asked for another workshop in the near future. Five people have inquired about receiving a copy of the slideshow after the workshop. Overall, there was great feedback for all attendees.

7.2 Accessible Community Garden Project

B. Davidson reported the application to the Community Foundation Grey Bruce for the Accessible Community garden was not successful.

B. Davidson reported that the Walkerton Action Committee's All-You-Can-Eat Spaghetti Fundraiser was held on Monday, October 29, 2018 at Pizza Delight in Walkerton and raised \$950.00 for the Accessible Community Garden Project.

Ecoraster Installation Workshop- Saturday November 3, 2018

and the Walkerton Action Committee on Saturday, November 3 from 9:00 a.m. to 12:00 p.m. The pavers were installed to level a portion of the garden to allow for an accessible entrance and in preparation for accessible garden bed installation.

7.3 Zero Waste Community Event Kit

Patterson informed the Committee that at their October 9, 2018 Meeting, Council approved the Brockton Zero Waste logo recommended by the Committee for use on municipal materials, publications, and media as a way to encourage staff and residents to choose zero waste alternatives to help divert waste from municipal landfill facilities.
