Thank you for providing the County with the opportunity to comment on the Holding Symbol Removal for File Z-2021-038 McKague at 203 Cargill Road, in the Municipality of Brockton.

The Zoning By-law Amendment for the site, By-law 2021-105, includes holding provisions which can only be removed by Council once it is demonstrated to the satisfaction of the Municipal Zoning Administrator, Saugeen Valley Conservation Authority and Saugeen Ojibway Nation that the conditions of the Holding Removal have been satisfactorily addressed. If those departments/agencies are not satisfied and have not provided the Municipality with a clearance letter in support of the Holding Removal, it is the opinion of Bruce County staff that the Holding Removal is premature.
