Report:

Background:

The Saugeen Valley Conservation Authority attended Council in November, 2018 seeking support for additional Greenock Swamp signage to assist in wayfinding for its tourism initiatives at the site in Cargill. Their summer tours, "Legends of the Great Swamp" have been tremendously popular among residents and visitors. In 2018 six tours were offered and each one sold out, including a new one, "Bootlegging Lore of the Great Swamp," which included the Walkerton jail and tales of Mickey McArthur.

Brockton's Community Development Coordinator attended a recent meeting of the Greenock Swamp Promotional Committee and learned of plans for 2019. They include increased media exposure, a revised brochure, more children's activities and continuation of the Cargill Visitor Centre and train tours, operated by students over the summer months. They are also considering ways to slow down traffic during the summer because of safety concerns with the train.

The group is eager to establish a "pop-up" store in Cargill showcasing the work of local artisans, and may approach the Municipality to apply for Trillium funding.

Three swamp tours are already booked for May 2019.

Group members voiced a need for improved signage, as some visitors reported getting lost on the way.

Analysis:

Brockton staff support the recommendation of additional wayfinding signage to the Greenock Swamp to increase awareness of this unique natural environment, its heritage, and its culture, which are all enhanced by the Greenock Swamp tours.

Staff determined three locations on municipally owned property that would be appropriate for additional signs to be placed. The proposed signs measure 30x8 inches, and would cost \$56 a piece. Please see attached map for location markings.
