By-Law 2019-006

Being a By-Law to Adopt a Municipal Occupational Health and Safety Policy for the Municipality of Brockton.

Whereas The Council for The Corporation of the Municipality of Brockton deems it expedient to establish policies;

And Whereas the *Municipal Act S.O. 2001, c 25, Section 5(3)*, as amended provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9, shall be exercised by by-law;

And Whereas Section 25, subsection 2, item (j) of the *Occupational Health and Safety Act, R.S.O. 1990, Chapter 0.1*, as amended, states that an employer shall prepare and review at least annually a written occupational health and safety policy and develop and maintain a program to implement that policy;

And Whereas section 9, subsection 2, item (a) of the *Occupational Health and Safety Act, R.S.O. 1990, Chapter 0.1*, as amended, states that a Joint Health and Safety Committee is required at a work place at which twenty (20) or more workers are regularly employed;

And Whereas the Council of the Corporation of the Municipality of Brockton is supportive of work place safety and the protection of its employees from injury;

Now Therefore the Council of The Corporation of the Municipality of Brockton enacts as follows:

- 1.0 That The Corporation of the Municipality of Brockton Council hereby amends By-Law 99-30 by adopting a revised Municipal Occupational Health and Safety Policy as contained in the attached Schedule "A" to this By-Law.
- 2.0 That By-Law 2006-14, By-Law 2014-044, By-Law 2015-024, By-Law 2016-008, and By-Law 2017-009 are hereby repealed.
- 3.0 This By-Law shall come into full force and effect upon final passage.
- 4.0 This By-Law may be cited as the "Adopt Municipal Occupational Health and Safety Policy By-Law".

It is in the best interest of all parties to consider health and safety in every activity. Commitment to health and safety form an integral part of this organization, from the council and senior management team to the workers.
