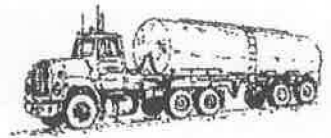
To whom this may concern,

It has been brought to my attention that the state of the road has been getting worse and larger pot holes are forming. It is especially bad now since the mild spell and the freeze again. There are ruts mixed in with the pot holes. I am concerned from a safety aspect and also from a maintenance and repair aspect to our equipment.

Our company makes a conscious effort to travel on these concession roads with as little load on as possible. We are well aware of the potential weight on our units and therefore try to be a good community partner and ag industry partner.

I am asking for council and staff to strongly consider this road for repair when looking at your road repair plan for the upcoming year.
