5. **ITEMS FOR DECISION/DISCUSSION**

5.1 Organics Handling

Gregg Furtney provide verbal update on current programs and options being researched as follows.

Southgate

- Use Miller Waste for their curbside collection

Waste Management

- Provide collection and take material to All Treat in Arthur
- Would require 5 to 7 year agreement to provide collection

Bruce County

- Updating Waste Management study to be presented in 2023
- Municipal Innovation Council, a group of CAOs in Bruce County in conjunction with Nuclear Innovation Council completed study using Dillon Consulting

The Committee noted the need to review further opportunities to implement organics diversion to increase landfill site life and reduce leachate strength.

6. ITEMS FOR DISCUSSION

6.1 Ontario Landfill Space

Reviewed article from the Globe and Mail regarding current low costs for disposal which creates economic disincentives for waste reduction and use of secondary material.

Bill 197 passed in 2020 requires local municipal council resolutions to support any landfill site within 3.5 kilometers of an adjacent municipality.

6.2 Pickup/Recycling Service for Agricultural Plastics

Information provided by Switch Energy Company that provides pickup/recycling service for agricultural plastics.

Gregg Furtney advised that there is currently a pilot project with Clean Farms for agricultural plastic wrap at the Brant site.

6.3 2022 Landfill Budget

The committee reviewed the landfill budget status to March 31st.

Tim Elphick inquired about WSIB rebates which staff have confirmed that rebates are to be issued starting in April due to surplus funds.

6.4 Landfill Quantities

The committee reviewed the landfill quantities to March 31st with no concerns.
