Background:

The following report outlines By-Law Enforcement activity update from April 1st, 2022- June 15th, 2022.

Analysis:

By-Law Enforcement Staffing Update

With By-Law Enforcement and Animal Control Officer Lisa MacDonald going on leave at the end of June, Nathanial Dodds has been appointed as By-Law Enforcement and Animal Control Officer and commenced employment with the Municipality at the end of May in an overlap and transition period with Lisa MacDonald.

False Alarm By-Law

Municipal staff began administering the False Alarm By-law on April 1st, 2022. Staff received the Data Analysis report for the month of April and there was a total of 13 (thirteen) At Fault False Alarms. Alarm Holders were provided education of the municipal by-law. Additionally, staff received the Data Analysis report for the month of May, and there was a total of 6 (six) At Fault False Alarms. A Notice of Collection of fees were administered to 3 (three) Alarm Holders who had multiple occurrences.

Parking

The Municipality of Brockton's Consolidated Traffic and Parking By-Law was amended to include definitions, abandoned vehicles, towing and parking and administration provisions. The updated amendments will assist the by-law department in resolving by-law matters internally.

Staff responded to complaints, conducted patrols and issued 17 Parking Infraction Notices. Municipal staff will continue to proactively monitor and patrol downtown parking in Walkerton to ensure compliance with By-Law 2020-052.

Complaints

The Municipality of Brockton received a total of 33 complaints from April 1st, 2022- June 15th, 2022. Staff have closed 19 of the 33 complaints and are diligently working to achieve compliance with the remaining by-law matters.
