Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number CLK2022-15 - Canadian Indigenous Flag, prepared by Sarah Johnson, Deputy Clerk and in doing so ratifies the decision of the Clerk to order the Canadian Indigenous Flag and raise the flag for a week-long period beginning June 20, 2022 until June 24, 2022 in recognition of Indigenous Peoples Day on June 21st and Indigenous History Month in June.

And further that Council approves bringing a By-Law forward to adopt the amended Flag Etiquette and Protocol Policy including an exemption for raising the Canadian Indigenous Flag annually.

Report:

Background:

The Municipality of Brockton passed Resolution 21-27-16 recognizing the Truth and Reconciliation Commissions Calls to Action to redress the legacy of residential schools and advance the process of Canadian reconciliation. As part of this resolution, several actions were approved that staff would implement within Brockton, including the purchase of Every Child Matters flags, and raising the flags half-mast annually in September in recognition of National Day of Truth and Reconciliation.

Analysis:

June is Indigenous History Month, and Indigenous Peoples Day occurs on June 21^{st} , 2022. As part of our continued implementation to address the calls to action, and in recognition of these two events in June, the Clerk authorized staff to order a $36'' \times 72'' \times 2100$ Nylon Canadian Indigenous Flag to raise at the community flag pole.

The Canadian Indigenous Flag was designed to represent First Nations in Canada, and bring a better understanding of the First Nations to our country with a unified vision of our diversity.

Staff have prepared the flag to be raised at the community flag pole the week of June 20-24, 2022.

The flag will be raised each year during the month of June in recognition of Indigenous History Month and Indigenous Peoples Day. Staff have amended the Flag Etiquette and Protocol Policy to include an exemption for the Canadian Indigenous Flag.
