### Report:

#### Background:

Brockton Municipal Council has asked for a regular project update for the Walker West Booster Pumping Station. The May 2022 project update was Report Number UT2022-11, provided to Council at their May 24, 2022 Council Meeting.

#### Analysis:

There has been a significant amount of work completed since the last Council Update.

- 1.) Hydro One was in and completed their work.
- 2.) Perimeter Fencing is being installed
- 3.) The new lighting panel was installed
- 4.) The ATS Section 6 arrived from the vendor and will be installed the week of June 20<sup>th</sup>, 2022
- 5.) The SCADA programming is complete
- 6.) Normal day to day demand pumps are online and the new pressure zone can be operated as intended.
- 7.) Engineers, contractor, electrician, programmer, and operating authority have been onsite to run through checks and scenarios.
- 8.) The High Demand Pumps, for fire flow, are currently offline with further testing taking place the week of June 20<sup>th</sup>, 2022. Chief Wells has been notified of the delay and is continuing with his contingency plan.

9.) BM Ross and Veolia Staff have been testing and recording pressures at various hydrants throughout the new pressure zone.

Staff are very pleased that the project is nearing completion. Although the high demand fire flow pumps are still offline, the normal day to day pressure pumps are online and feeding the homes and providing the required water pressures.
