Dear Mayor Peabody:

As a follow-up to the previous correspondence from the Ontario Provincial Police (OPP) Commissioner Thomas Carrique dated January 28, 2022, I wish to inform you that we have conducted a review of occurrences that are typically generated by routine processes and procedures within courthouses to whereupon charges are laid against offenders for not appearing in court.

We have studied patterns of such occurrences throughout the province over several years and noticed different trends, including some that appeared to be influenced by COVID-19 pandemic impacts on the courts. We have conducted detailed reviews of Fail to Appear occurrences to try and gain a clearer understanding of the degree of police activity related to these occurrences.

As a result of this review, we have decided that our method of allocating calls for service costs to municipalities could be improved by removing certain courthouse activity-related occurrence types from our list of billable calls for service. In total five occurrence types are being removed: "Fail to Attend" occurrences and four bail violations occurrence types related to offenders being absent from court.

This change will be effective for the 2023 billing year with no retroactive adjustments to previous billing years. Your municipality's 2023 Annual Billing Statement will include the recalculated amount as well as an explanatory note.

We maintain that the allocation of municipal policing costs under the OPP Billing Model methodology ensures a fair cost-recovery process that continues to provide a high level of cost stability for municipalities receiving their policing services from the OPP.

We appreciate the municipality bringing this matter to our attention and thank you for helping us to make improvements in our processes to ensure municipal policing costs are allocated on a fair and equitable basis. We hope this revision to billable calls for service occurrence types addresses the concerns raised in the Municipality of Brockton's request for a costing review.
