## Background:

As requested by Council this report has been prepared for information purposes pertaining to development at 2 Ontario Road within the East Ridge Business Park.

#### Analysis:

The owner of 2 Ontario Road within the East Ridge Business and their consultants have engaged in preconsultation with Municipal Staff, our Engineer Consultants and County Staff pertaining to development on the subject lands. Preliminary draft proposals of the site development and plans were received and have been reviewed with comments provided back to the Owner and their consultants. The proposed site plan received to date will be subject to a Planning Application and Approval for relief of the provisions of the Municipal Zoning By-Law. Municipal and County staff have advised of the Planning Application and Approval process and timeframes. Staff and County comments have also provided with respect to amending the plans to be in conformity with the Municipal Zoning By-Law to the Owner. Municipal Staff are following the Site Plan Control Application and Approval Process. It is Municipal staff's understanding that the Owner and their Consultants are working on the submission set of plans and studies that will form part of a potential Planning Application and the Site Plan Approval process that will incorporate and address comments provided by the Municipal Staff and our Engineer Consultants and Bruce County Planning Staff acknowledged during the pre-consultation review process.
