### Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number DRAIN2022-08 - Dales Drain Branch Petition for Drainage Works Road 20, prepared by Stephen Cobean, Drainage Superintendent, and in doing so accepts the petition for new drainage works for Part Lot 16, Concession 9 and 10 in the former Township of Greenock and that Council appoint an Engineer to make an examination of the area, by By-Law or Resolution, (*Drainage Act RSO, 1990, Section 8*) once the 30 day notification period required under Section 5(1) of the *Drainage Act* has expired.

### Report:

#### Background:

This report is in response to a 'Petition for Drainage Works by Owners - Form 1', received from Mr. Tim Dales, 1015 Bruce Road 20, Cargill, ON, N0G 1J0. The petition has been signed by Tim and Nancy Dales.

The petitioners are requesting that the existing private ditch located on their property located on Part Lot 16, Concession 9 and 10 in the former Township of Greenock be enclosed and that the new closed drain be re-directed to the proposed Dales Municipal Drain in order to provide for a sufficient outlet for their property.

#### Analysis:

It is recommended that the Municipality of Brockton accept the Petition and proceed with the appointment of a Drainage Engineer after the required 30 day notification period required under Section 5(1) of the *Drainage Act* has expired.

Please note that if the Petition fails to comply with Section 4 of the *Drainage Act* at the 'meeting to consider the final report' because one or all of the petitioners have decided to withdraw their names, the original petitioners will be liable for all costs incurred on the project to date.
