Financial Statements - December 2021

-tonnage diverted from landfills for December 2021 totalled 489.63 T

-year to date tonnage diverted from landfills totalled 5,539.94 T

-net income for December 2021 totalled \$7,322.09

-year to date net income totalled \$22,969.82, comparing to the net loss in 2020 totalling \$188,869.

Discussions were held concerning expenses related to Covid-19. Karrie noted that she will reach out to the municipalities and the auditor for assistance whether we can claim these expenses to the business.

Item 3: Other Business

Vince presented the 2022 Capital Budget. Mark Ireland inquired whether or not some of these expenses should fall under operating expenses instead of capital. Karrie noted that some expenses will not be used, if these amounts were placed into the operating budget, that would increase the member per household cost dramatically.
