- 4.1 Planning Report Zoning By-Law Amendment Z-2022-114

Benito Russo, Bruce County Planner, provided an overview of the application and described the characteristics of the subject property. The applicant was intending to sever the dwelling that was surplus to the ongoing farm operation. The non-farm lot would be rezoned to general agricultural special to identify that any existing buildings would need to comply with the provision of the zoning bylaw to prevent development in the future with a holding provision to ensure any lands that may have archeological potential would only be developed after an archeological assessment was completed.

The official plan set out the policies to be applied for a surplus farm dwelling to occur. In this case, the application met all requirements as set out in the Official Plan. The application was circulated to the commenting agencies with no comments being received.

There were no members of the public in attendance in person or via zoom wishing to participate in the public meeting. The Applicant did not make any submissions to Council about the application.

Benito Russo, Bruce County Planner, provided an overview of the application for a surplus farm dwelling severance. Mr. Russo summarized the location and characteristics of the application, noting the agricultural lands would be retained for agricultural purposes.

The severed lands would be rezoned to a special agricultural zone to prevent future development contrary to the agricultural uses and to recognize any potential archeological potentials.

The official plan again set out the requirements in order for this kind of severance to be approved. This application conformed with all the requirements within the Official Plan. No comments were provided by the commenting agencies.

Mayor Peabody provided an opportunity for the applicant to speak in support of the application. No other members of the public in attendance had any additional comments to add.
