Consent Application Notice

A change is proposed in your neighbourhood: The purpose of the application is to facilitate a surplus farm dwelling severance of a +/- .8 ha lot from a +/- 40.47 ha agricultural parcel. To facilitate the severance, the Zoning By-law will be amended to prevent any future dwellings on the agricultural lands, recognizing the existing buildings on the severed parcel, and a holding is proposed in areas of high archeological potential.


Know your rights

Section 53(19) of the Planning Act outlines rights of appeal for Consent applications.

If a person or public body that files an appeal of a decision of the County of Bruce in respect of the proposed consent does not make written submissions to the County of Bruce before it gives, or refuses to give, a provisional Consent, the Ontario Land Tribunal may dismiss the appeal.
