- 4.1 Planning Report Zoning By-Law Amendment Z-2022-113

Julie Steeper, Bruce County Planner outlined the ways in which members of the public could receive updates regarding the application.

It was noted the purpose of the application was to sever lands and add them to the adjacent property as a minor lot line boundary adjustment. The property was located in the Town of Walkerton and surrounded by residential and agricultural uses. The lands to be severed were designated as environmental protection and the applicable planning documents allowed for lot line adjustments. Adjacent properties would not be significantly impacted and the adjustment would sever the lands along the natural watercourse. The lot line adjustment was not being proposed to facilitate development and a holding was being proposed until such time as an archeological assessment was obtained for the lands.

Comments were received from the Saugeen Valley Conservation Authority noting the proposal was acceptable to that organization.

Ms. Steeper responded to questions from Council and clarified that no development was being proposed as part of the application.

The owner of the property next door, Mario Garcia, spoke in support of the application.

Ms. Steeper clarified that having a part of the property zoned environmental protection prevented development which may be due to flooding or other natural hazards, but did not mean that additional measures were being taken to protect the environment on those lands.

# 4.2 Planning Report - Zoning By-Law Amendment Z-2023-006

Benito Russo, Bruce County Planner, described the methods by which individuals could receive updates about the application.

Mr. Russo provided an overview of the application to facilitate a severance of a property that had inadvertently been merged, as the property had two residences and a barn. There was no new development proposed for the application and the residences had been lawfully constructed. The remaining agricultural property would be rezoned to recognize its smaller size for agricultural uses and an archeological assessment would be required prior to any development on areas of the lands with high archaeological potential.

Mr. Russo recommended approval of the application as it conformed with the official plan and other applicable policies.

The applicants were in attendance but did not make comments about the application. There were no other individuals in attendance who indicated they wanted to participate in the public meeting.

# 4.3 Planning Report - Zoning By-Law Amendment Z-2023-004

Mr. Russo summarized the ways that an individual could receive updates on the application. Mr. Russo summarized the application for a surplus farm dwelling severance along Highway 9. The remaining parcels would be rezoned to ensure any existing structures or building would need to comply with the provisions of the by-law.

The environmental protection areas of the property would remain unchanged. The application met the relevant policies relating to surplus farm dwellings such that Mr. Russo was recommended the application be approved.

The applicant did not comment on the application and there were no members of the public in attendance who indicated they wanted to participate in the public meeting.

## 5. Delegations

5.1 Monteith Brown Planning Consultants - Bruce County Official Plan Review

Jay McGuffin and Eric Steele were in attendance to answer any questions from Council about the planning analysis for the Walkerton proposed settlement area expansion.

Jay McGuffin responded to questions from Council about the history of the settlement area as being part of the original farm parcel. It was noted that there were proposed changes to the Provincial Policy Statements that may assist Brockton in expanding the Walkerton settlement area, as the proposed statements did not require a comprehensive review be undertaken to justify a boundary expansion. Mr. McGuffin noted, however, that the proposed changes were only within the commenting period such that the final legislation may be very different in the future.

It was noted that there were very little commercial lands available such that some additional expansion would be required for economic development.

# 7.1 Motion - Robinson/South Street, Walkerton Pedestrian Crossover

Councillor McLean described his reasons for bringing the motion forward to obtain information about what may be involved in improving visibility for pedestrians in that area.

Whereas Sacred Heart High School is located on Robinson Street in the Town of Walkerton in a Community Safety Zone of 40 km/hr;

And Whereas Robinson Street is a one-way street;

And Whereas the Municipality of Brockton's Consolidated Traffic and Parking By-Law restricts parking on the North side of South Street from Robinson Street to the Eastern Terminus;

And Whereas the Municipality of Brockton's Consolidated Traffic and Parking By-Law restricts stopping 30 meters East of Robinson Street from 8:30 a.m. to 4:30 p.m.;

And Whereas Robinson and South Streets are widely accessed by young adults in Brockton's community and neighbouring communities attending Sacred Heart High School;

And Whereas Section 140 of the *Highway Traffic Act, R.S.O. 1990, c. H.8* defines a Pedestrian Crossover as "any portion of a roadway distinctly indicated for pedestrian crossing by signs on the highway and lines or other markings on the surface of the roadway as prescribed by the regulations";

And Whereas the Council of the Municipality of Brockton advocates for community safety and wishes to pursue the installation of a Pedestrian Crossover to ensure individual's safety when crossing the road at Sacred Heart High School;

Now Therefore Be It Resolved That the Council of the Municipality of Brockton directs staff to bring forward a report at a future Council Meeting considering the installation of a Pedestrian Crossover located on South Street connecting the sidewalk on Robinson Street to South Street in order to allow individuals to safely cross over to South Street.

Whereas the Municipality of North Perth passed a resolution on March 6, 2023 regarding school bus stop arm cameras, noting that the administrative and financial costs to establish the required Municipal Administrative Penalty program under the Highway Traffic Act, and its regulations, are substantial and maybe out of reach for small or rural municipalities that have insufficient amounts of traffic to generate the required funds to offset the annual operational costs of a municipal Administrative Penalty program;

Now Therefore Be It Resolved That the Council of the Corporation of the Municipality of Brockton hereby supports the resolution made by the Municipality of North Perth urging the Provincial Government to:

- a. Require all school buses to have stop arm cameras installed and paid for by the Province for the start of the 2023-2024 school year; and
- b. Underwrite the costs for the implementation and on-going annual costs for Administrative Monetary Penalties in small and rural municipalities.

And Further that a copy of this resolution be forwarded to the Municipality of North Perth, Premier Doug Ford, Attorney General Doug Downey, Minister of Education Stephen Lecce, MPP Lisa Thompson, and AMO.
