Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number REC2023-13 - Reduced Rental Fee Request – Susan Seitz, prepared by Trish Serratore, CFO/Acting Director of Community Services and in doing so approves staff's recommendation to maintain charging the hourly rate as outlined in the Fees and Charges By-Law.

Report:

Background:

On April 25, 2023 staff received the attached letter from Susan Seitz requesting a reduction in the Walkerton Auditorium rental.

Analysis:

Mrs. Seitz has previously rented the Walkerton Library; however, this space was not large enough for what she needed. Mrs. Seitz called the Brockton Recreation staff to book the Walkerton Community Centre Auditorium due to the larger space and flooring.

It was more cost efficient for Mrs. Seitz to go on the hourly rate which is \$36.00/hour + HST vs the daily rate of \$315 + HST. Mrs. Seitz total contract was \$504 + HST (\$569.52 total)

Staff recommend based on Mrs. Seitz needs that the Cargill Meeting room would be a great option and it is \$125 + HST per day, however this option was not suitable as she preferred to be in Walkerton.

Based on the alternative location offered to Mrs. Seitz and to avoid setting precedence for future requests, staff do not recommend reducing the auditorium rental fee.

It should be noted that while Council chose to waive the rental fee for the Truth and Reconciliation Group, this decision was linked to Brockton commitment towards reconciliation with Canada's Indigenous People and in

deference to the calls to action made by the Truth and Reconciliation Commission. It should not be conflated as granting waivers to all not-for-profits, service clubs or commercial businesses.
