### Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number PW2023-15 - Robinson and South Street Crosswalk, prepared by Nicholas Schnurr, Director of Operations and in doing so approves a By-Law coming forward to amend the Consolidated Traffic and Parking By-Law to include the addition of a school crossing at the intersection of Robinson and South Street in Walkerton.

### Report:

#### Background:

On May 23, 2023, at the Brockton Council meeting, council received report number PW2023-12 Robinson and South Street, Walkerton Pedestrian Crossover, which detailed the request for a school crossing at the intersection of Robinson and South Street. According to the Amendments to Traffic and Parking By-Law Policy T02-2017-17, staff sought public input on the crosswalk to be reported to Council at the July 11, 2023 meeting.

#### Analysis:

The crosswalk location was [advertised to the public](#) for comment and letters were mailed out to residents within 120 meters of the crosswalk location as per the policy. To date, no members of the public have submitted written comment, concern or objection to the crosswalk.

Staff recommend that the crosswalk be included in the Consolidated Traffic and Parking By-Law. The uncontrolled crossing will come into effect after the by-law is updated and the crossing is fully installed. The crossing is anticipated to be complete prior to the 2023-2024 school year.
