

# The Corporation of the Municipality of Brockton



## By-Law 2023-074

---

### Being a By-Law to Rescind the Water Service Agreement with the Corporation of the Town of Hanover and Hosskan Holdings Inc.

---

**Whereas** the *Municipal Act S.O. 2001, c 25, Section 5(3)*, as amended provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9, shall be exercised by By-Law;

**And Whereas** Section 11 of the *Municipal Act, 2001, S.O. 2001 c. 25*, as amended, allows a municipality to provide any service or thing that the municipality considers necessary or desirable for the public.

**And Whereas** Section 19 of the *Municipal Act, 2001, S.O. 2001 c. 25*, as amended allows a municipality to provide a service or thing in an area in another municipality with the consent of the other municipality.

**And Whereas** Section 398(2) of the *Municipal Act, 2001, S.O. 2001 c. 25*, as amended allows a municipality to add unpaid municipal fees to the property owner's respective tax roll and collect them in the same manner as municipal taxes.

**And Whereas** the Corporation of the Municipality of Brockton entered into a Water Service Agreement with the Corporation of the Town of Hanover and Hosskan Holdings Inc. to provide water service to an unserved property located in the Municipality of Brockton and known as 41 Bruce Road 22, within the Brant Township, legal described as PT LT 72 & 73 CON 2 NDR BRANT AS IN R186721, R191228 & PTS 20, 22 & 24 3R4223, S/T & T/W R186721; S/T R320800E, bearing parcel identifier number 33195-0352 on May 23, 2023 as per By-Law 2023-060;

**And Whereas** Hosskan Holdings Inc. notified both the Corporation of the Municipality of Brockton and the Corporation of the Town of Hanover that they no longer wish to continue with the Water Service Agreement and have pursued alternate arrangements for their property;

**Now Therefore** the Council of The Corporation of the Municipality of Brockton enacts as follows:

- 1.0 That the Corporation of the Municipality of Brockton Council hereby authorizes rescinding the Water Service Agreement with the Corporation of the Town of Hanover and Hosskan Holdings Inc.
- 2.0 That By-law 2023-060 be hereby rescinded.
- 3.0 This By-Law shall come into full force and effect upon final passage.
- 4.0 This By-Law may be cited as the "Rescind Town of Hanover and Hosskan Holdings Inc. Water Service Agreement By-Law".
