That the Council of the Municipality of Brockton hereby receives Report Number PW2023-18 - Bruce Power Soccer Complex Parking Lot Relocation Tender, prepared by Nicholas Schnurr, Director of Operations and Sonya Watson, Chief Administrative Officer and in doing so awards the contract to Kurtis Smith Excavating Inc. in the amount of \$384,200.00 plus HST.

Report:

Background:

The Bruce Power Soccer Complex Parking Lot has been identified as requiring relocation and upgrading due to continuing development in the East Ridge Business Park.

There were three (3) tender submissions. B. M. Ross reviewed all tender submissions for completeness and accuracy and provided the Municipality with a letter of recommendation. That letter of recommendation is attached to this report. B. M. Ross is recommending that the Municipality award the contract to Kurtis Smith Excavating Inc. in the amount of \$384,200.00, plus HST.

Analysis:

Council approved proceeding with the relocation of the parking lot in conjunction with the new soccer concession stand build this fall and to continue to advance the Phase 3 construction plans for the East Ridge Business Park. The lowest tender bid is lower than final estimates provided of \$402,845 + HST based on final design and provides contingency, within the budgeted estimate for engineering costs and unforeseen construction circumstances.

Staff are supporting the recommendation from B. M. Ross for the contract to be awarded to Kurtis Smith Excavating Inc. in the amount of \$384,200.00, plus HST. Work is scheduled to be completed by Friday, November 17, 2023.
