4. Public Meetings Required Under the Planning Act

4.1 Planning Report - Zoning By-Law Amendment Z-2023-043

Councillor Kuhnke acted as Chairperson for the Public Meeting as Mayor Peabody had declared a conflict of interest and did not participate in the Public Meeting.

Benito Russo, Bruce County Planner, informed everyone in attendance how they could receive updates with respect to the application. Mr. Russo provided an overview of the application and the character of the surrounding area. The application was to rezone an agricultural lot and a conservation area with a reduced size. The purpose of the application was to protect and enhance bird habitat within the County. The general land policies and detailed land access were an efficient use of land and the proposed zoning by-law amendment was in conformity with the additional conservation efforts.

Mr. Russo noted that the application met the policies in the official plan and the applicable provincial policy statements, advising that the application is focused on conservation and enhancing natural features.

The application was circulated to neighboring communities, and had been modified based on further discussion with the applicant in order to indicate that only a portion of the property would be reserved for conservation purposes. Mr. Russo noted comments received from the public, and explained that the basis of those comments could be better addressed outside of the public planning process.

Don Scott from Cuesta Planning Consultants spoke on behalf of the Eco Bio Conservancy for the purpose of having the conservancy created. Mr. Scott noted how active the conservancy was in the County of Bruce to preserve the natural environment in perpetuity. A member of the family had requested that the application be delayed, however, the proposal was altered to reduce the size of the hectares required for the conservancy in order to address the concerns of the potential objectors. Mr. Scott spoke in support of recommending that the application be approved, and indicated that the concerns had been resolved on behalf of Elda Threndyle.

Gene Threndyle represented his mother Elda Threndyle, and indicated that Ms. Threndyle wished to move forward with the revised application, summarizing the concerns brought forward by the potential objectors, and noted that Ms. Threndyle had discussed the matter with her lawyer and financial advisor, and wished to proceed with the application.

There were no members of the public who wished to participate when given the opportunity to do so.

Nicholas Schnurr, Director of Operations, responded to questions from Council about the operations at the Hanover/Walkerton Landfill site to reduce the number of seagulls.

Councillor Elphick advised that the Hanover/Walkerton Waste Management Committee had met and discussed this issue for some time. Resident concerns were noted; however, the sea gull counts are within the set threshold. Councillor Elphick spoke to other mitigation efforts that were used in the past, and future options to consider.

Council noted that Lake Rosalind and Marl Lakes struggle to provide safe drinking water and water levels suggested that staff monitor the amount of sea gulls to ensure the mindfulness of the Safe Drinking Water Act.

Council inquired on previous mitigation measures proposed for the landfill site, and suggested that the Hanover/Walkerton Waste Management Committee consider an experiment using lasers to deter the seagulls away from the landfill.

Action: Staff to notify the Hanover/Walkerton Waste Management Committee on Council's recommended proposal to consider an alternative proposal to address the seagull concerns at the landfill.
