6.1 Municipal Office/ Canada Post Relocation of Accessible Parking Spaces
Chairperson McLean commented on the enthusiasm displayed by the
Committee.

Joseph Martel provided a draft site plan he had provided and commented on the spaced that could be made available if the parking was reconfigured, including the types of accessible spaces that would be required.

The Committee discussed the dimensions of the spaces in relation to the curb cuts to ensure that the other accessible spots would still be free from barriers. It was also noted that additional signage would still be required.

6.2 Bruce Power Regional Soccer Park Changeroom and Concession Building

Fiona Hamilton, Director of Legislative and Legal Services (Clerk) informed the Committee that the Bruce Power Regional Soccer Park Washroom Building would have exterior outlets included.

The Committee commented on the outdoor outlets throughout Brockton that should be checked to ensure they were operational.

Action: The Committee provided direction that the outlets be checked when recreation staff were maintaining open spaces and trails.

The suggestion was made that a sticker could be printed and put on the electrical outlets with contact information if a member of the public noticed an outlet was not operational.

It was noted that GIS could create a map showing the location of electrical outlets for charging as well as accessible bathrooms.

6.3 Downtown Sidewalk Signage

The Committee discussed some of the ongoing downtown sidewalk challenges.
