Recommendation:

That the Council of the Municipality of Brockton hereby accepts Report Number CLK2023-22 – Saugeen Municipal Airport and Member Municipality Correspondence for information purposes and authorizes a staff report coming forward evaluating the service and the potential implications of a sale or dissolution of the organization.

Report:

Background:

During budget deliberations, Council of the Municipality of Brockton had the opportunity to consider the ongoing funding contribution made to Saugeen Municipal Airport, noting the large fundraising goals that had been included in the proposed budget. Council of the Municipality of Brockton had also identified the need to evaluate the service and the benefits it provides to all Brockton residents.

Analysis:

Given the context described above, Council of the Municipality of Brockton has directed that staff send a letter to the Municipality of West Grey and the Town of Hanover inviting them to consider a sale of the asset, or a voluntary winding up in accordance in s. 230(1) of the Corporation Act, R.S.O. 1990, c. 38. The letter that was sent to the other municipalities and the Saugeen Municipal Airport has been attached to this Report.

Staff also suggest that a Council authorize the preparation of a comprehensive report evaluating the service and the potential implications of a sale or dissolution of the asset.

Additional correspondence that was received by the Saugeen Municipal Airport has also been attached to this report.
