# 5.1 Planning Report - Minor Variance Application A-2023-008

Benito Russo, Bruce County Planner, informed individuals how to receive updates about the application. Mr. Russo provided an overview of the application to allow for the expansion of a service related business and the relief that was being requested, including a request to amend the parking spaces to 7 from the

required 11. The property had frontage along a provincial roadway such that approval from the Ministry of Transportation was required.

Mr. Russo summarized the four-part test for a minor variance and the reasons why the application met the test. It was noted the site was under a number of site plan control processes involving the Ministry of Transportation and the Municipality of Brockton.

The property was fitting with the character of the area and would have a minimal impact on the surrounding uses.
