Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number PW2023-22 – 2023/2024 Winter Sand Tender, prepared by Nicholas Schnurr, Director of Operations, and in doing so awards the contract to Kurtis Smith Excavating Inc. in the amount of \$90,200 plus HST.

Report:

Background:

Every year the Municipality of Brockton issues a tender for the purchase of winter sand. Staff utilize approximately 2,500 tonnes of sand at the Brant Shop and 1,500 tonnes of sand at the Greenock Shop, to adhere to the Minimum Maintenance Standards for Municipal Highways as set in Ontario Regulation 239/02, as part of the winter maintenance and snow plow operations for the municipality.

Staff put out an RFT for the purchase of the winter sand and to enlist the services for the stacker and operator (to mix the sand with salt and pile it in the domes at the shops). There were three bids received, with the lowest being Kurtis Smith Excavating Inc. Staff are satisfied with the tender results as outlined below.

Analysis:

Staff recommend that the Council of the Municipality of Brockton accept and award the contract to the lowest tender, Kurtis Smith Excavating Inc: at \$79,750 for winter sand and \$10,450 for the stacker and operator services, total of \$90,200 plus HST.
