# The Corporation of the Municipality of Brockton



By-Law 2023-093

Being a By-Law to Establish, Ratify, and Impose Fees and Charges for Goods and Services Provided By the Municipality of Brockton.

Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 391(1) authorizes a municipality to impose fees or charges on any class of persons,

- a) for services or activities provided or done by or on behalf of it;
- b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and
- c) for the use of its property including property under its control.

**And Whereas** Municipal Councils have the authority to establish rates and fees under various Acts, and the Council of the Corporation of the Municipality of Brockton deems it expedient to pass a by-law establishing certain fees and charges;

And Whereas the Municipal Act, 2001, S.O. 2001, c. 25, Section 398 (2) authorizes the treasurer of a local municipality to add fees and charges imposed by the municipality or local board, to the tax roll for the real property for which the owner or owners are responsible for paying the fees and charges;

Now Therefore the Council of The Corporation of the Municipality of Brockton enacts as follows;

- 1.0 That The Corporation of the Municipality of Brockton Council hereby develop and adopt a listing of fees and charges as contained in the attached Schedule "A" to this By-Law.
- 2.0 That the rates and fees as set out in Schedule "A" come into effect January 1, 2024 or as otherwise stated.
- 3.0 That should any fee or charge authorized by this By-Law remain unpaid or partly unpaid, then staff are hereby authorized to add any such outstanding amount together with any applicable interest to the tax roll for the real property of the owners responsible for paying the outstanding fee or charge.
- 4.0 That this By-Law shall supersede all others.
- 5.0 This By-Law shall come into full force and effect upon final passage.
- 6.0 This By-Law may be cited as the "2024 Fees and Charges By-Law".
