- 5.1 Victoria Jubilee Hall Update

Bob McCulloch, a representative from Victoria Jubilee Hall (owned by the Architectural Conservancy of Ontario), provided an overview of the major projects and the donations made by local partnerships, such as with the Bruce County Towne Players).

Mr. McCulloch also highlighted the projects that were planned for the next few years to preserve and maintain the building, such as repairs to the roof and investigation into an upgraded HVAC system.

Council noted the amount of capital improvements made over the past year. Council extended gratitude to the Victoria Jubilee Hall Executive and the number of volunteers who maintain this community landmark. Council commended the number of events and local talent on display, and the upgrades completed that

which ensure that the facility remains accessible and functional for years to come.

Henry Simpson, VJH Treasurer responded to a question from Council about the location of the asphalt roofing.

Council noted the increased involvement from youth and artist groups, and the vast use received from this historical building.

## 7. Business Arising From the Minutes

## 7.1 Motion on Importance of Natural Gas in Brockton

Councillor Hutcheon expressed frustration with the delay for EPCOR's leave to construction application for installing natural gas in Brockton. Mayor Peabody expressed support for natural gas noting that he had received a number of complaints from crop producers earlier in the day at Grey Bruce Farmer's Week about the need for natural gas in the agricultural sector.

Whereas EPCOR Southern Bruce Gas Inc. created a proposed distribution network for natural gas transmission pipelines which will service residences, commercial and industrial businesses along the route;

And Whereas the Municipality of Brockton committed to working with natural gas distributors to bring natural gas to our communities to remain competitive with our neighbouring municipalities and support our flourishing agricultural industry;

And Whereas rural communities require the same services and opportunities for natural gas expansion to support our economic development, residential growth, and access to reliable energy;

And Whereas the Municipality of Brockton have sent letters of support of EPCOR and Enbridge Gas' applications to the Ontario Energy Board to service rural areas of Brockton with natural gas access;

And Whereas there is a need in our community to support the continued growth of rural areas, including the impact to businesses, and agricultural producers, as well as supporting local, affordable housing developments;

Now Therefore Be It Resolved That the Council of the Municipality of Brockton encourages the Provincial Government at the Ontario Energy Board to move applications along at a rapid pace in recognition of the fact that this service is required in our community.

And Further that a copy of this resolution be forwarded to the Minister of Energy for consideration.
