That the Council of the Municipality of Brockton hereby receives Report Number FIN2024-02 – Donation Request for WDCS 80<sup>th</sup> Anniversary of VE Day Student Trip, prepared by Trish Serratore, Chief Financial Officer and in doing so approves a donation of \$\_\_\_\_\_\_ to Walkerton District Community School (WDCS) for the 80<sup>th</sup> Anniversary VE-Day Student Trip in 2025.

### **Report:**

### **Background:**

On December 9<sup>th</sup>, 2023 staff received a request from Mr. Troyer; the history teacher from Walkerton District Community School requesting financial support for the 80<sup>th</sup> Anniversary of V.E.-Day student trip. This trip will take students to the Netherlands commemorating the 80<sup>th</sup> anniversary of its liberation by Canadian forces during the Second World War. The trip is not planned to take place till 2025, however they are seeking financial support to allow students a cost-efficient opportunity to join this trip. The estimated cost per student is \$4,600 with the hope of having 18-24 students attend.

### **Analysis**:

Each year the Municipal Budget includes funding of \$5,300 available for various donation requests. These funds have historically been used for non-profit organization requests, special sport events sponsorship, and recently local school requests for significant events.

According to the Municipality of Brockton's Donation Policy F19-1999-05, a review of the request has been completed. Although it is challenging to determine the direct benefit to Brockton specific citizens, staff have determined that factor three would be most applicable for this request. The following chart illustrates the eligible donation amount for the organization:
