Background:

The Municipality of Brockton has received the annual donation request from Bruce Grey Mentorship and South Grey Bruce Literacy Council.

The South Grey Bruce Youth Literacy Council is a non-profit organization offering literacy programs to young people including training to adults who are struggling with reading, writing, and/or math. The organization is operational by volunteers and does not have paid staff. The financial support would provide financial assistance with virtual learning tools and assist with online educational opportunities.

The Bruce Grey Mentorship has been mentoring children and youth within the community since 2017. They offer a group program on a monthly basis, small community activities throughout the month and one to one match to focus on confidence and self esteem.
