For those that may have attended, this session is the same four hour format and topics with time for Q&As as done at the time.

(Delves into the statutory and non-statutory roles of MHCs, best practices for them to be effective, and their value to council and the community.)

• **Inventory, Evaluation and Designation: From Survey to Protection** (Examines the steps and processes in determining the cultural heritage value of

properties, how they lead to objective and knowledgeable advice to support effective decisions on the use of the appropriate legislative tools for protecting them. This includes recent relevant amendments to the *Ontario Heritage Act* as set out by Bill 108 and Bill 23.)

Please use the flyer to submit the number of those from your municipality you wish to register. The deadline for registration is Monday, April 29, 2024.

I've provided a number of these sessions over the last several months and they've proved to be welcome and effective.

My fee for this four hour cultural heritage conservation orientation session is \$400.00 plus \$120.00 travel time and \$15.00 per registrant for printed handout material. The

\$520.00 fee will be split by the number registrants per municipality and invoiced to their respective municipality plus the relevant printing fee. The more that register, the lower the cost per registrant. I will invoice each municipality following the session.

Printed copies of my resource material come in a folder which includes reduced versions of my three PowerPoint presentations for attendees to follow along with and to take notes, as well as 15 pieces of relevant Ministry of Culture InfoSheets and extracts.
