Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number BCCC2024-03 – Brockton Childcare Centre Organizational Review, prepared by Sonya Watson, Chief Administrative Officer and in doing so supports the recommendation of hiring Jennifer Kirkham of Mischevious Cat Productions to conduct an organizational review of the Brockton Child Care Centre for a cost of \$30,000 plus H.S.T. to be funded from a combination of grant funding and the child care reserve fund.

Report:

Background:

The services offered at the Brockton Child Centre support hundreds of families in the community. This service has grown substantially over the past 38 years originally servicing 55 children to now over 117 children plus the school aged programs of up to 50 children at Walkerton District Community School and up to 57 at St. Teresa of Calcutta Catholic School with over 25 staff. We have been so fortunate over the years to have committed, qualified and professional staff leading and providing care to children at the centre. With ongoing legislative changes in the childcare sector, pressures in the sector on the availability of ECE's, new financial formulas related to CWELCC funding and an increased number of families to service in this fast-paced environment, ensuring efficiency and quality in the service is on ongoing priority. The economic benefit the Brockton Childcare Centre provides to the community as a support to area families looking to settle here is of paramount importance.

Analysis:

To ensure the ongoing sustainability and viability of this essential service as a follow up to the April 9th Council Meeting staff have sought out the services of third-party childcare consultants to conduct an Organizational Review of the centre. This review will be important to help shape the future of the centre. This review will examine culture, human resources, quality, structure, services, and supports and customer experience all with

a goal of positioning the centre for the future in sustainable and viable way. Based on recommendations and the timeliness of this review we are recommending securing the services of Jennifer Kirkham of Mischevious Cat Productions a consulting firm which specializes in strategy and management consulting for the nonprofit and government sectors. Jennifer Kirkham is the President and CEO of Mischevious Cat Productions, and she will be the lead consultant on this project. Jennifer has been providing strategy and management consulting to the nonprofit and government sectors for the last 16 years, in such areas as: system transformation, community capacity building, strategic and community planning, program planning and evaluation, and operational and business process reviews. She has conducted work in the childcare sector for several lower-tier, Upper Tier and Cities across Ontario including the Couty of Bruce.

This review will include the engagement of childcare staff, families who use the centre, leadership, County of Bruce and the Child Care Committee through various methods.

Jennifer is available to start in May and this review is expected to take 3-4 months.
