
4.1 Physician Recruitment and Retention Committee Notes – May 1, 2024

Stephanie Pegelo informed the Committee of a proposal for a heart hub in Grey-Bruce. The Ministry is accepting proposals for 19 heart hubs in Ontario including homelessness and addiction recovery hubs. This will create supportive housing for individuals, such as transitional, income, and shelter space within the Owen Sound and Hanover areas. The Family Health Team currently partners with the Canadian Mental Health Association (CMHA) and if the proposal is accepted and funding is successful, this program can be expanded to serve more individuals in Grey-Bruce. Applications will be submitted at the end of the month, and community partners within the County are interested in this proposal.

10. Finance Report

The Committee reviewed the draft 2025 Budget which is similar to 2024. Brian Currie advised that the Committee has not incurred many expenses this year, with last year covering doctor travel and accommodation. Dr. McArthur noted that the Committee may receive some bills for travel/accommodation this year.

The Committee discussed the approximate amount in reserves, which will cover one (1) additional physician.

Kelly Fotheringham informed the Committee that the Teeswater Medical Clinic held a grand opening on October 4, 2024. The Clinic has one (1) physician, a nurse practitioner with the Family Health Team, a pharmacy, a massage therapist, and a hearing clinic part-time. The Clinic will be a good addition to Southern Grey-Bruce.
