#### **Recommendation:**

That the Council of the Municipality of Brockton hereby receives Report Number UT2024-17 - Grant Opportunity – Canada Housing Infrastructure Fund (CHIF), prepared by Nicholas Schnurr, Director of Operations and in doing so authorizes staff to submit an application to the CHIF grant for the Water Tower project utilizing GrantMatch.

#### **Report:**

#### Background:

At the February 29,2024 Brockton Council meeting, Council received a report authorizing the application to the Housing Enabling Water Systems Fund (HEWSF) for a new water tower and transmission line. If successful, the project could be funded up to 73% of all eligible costs. This would leave the remaining 27% to be funded by alternate means, preferably with DC charges.

On November 7, 2024, Sean Fraser, Minister of Housing, Infrastructure and Communities announced the launch of the Canada Housing Infrastructure Fund's \$1 billion direct delivery stream to provide communities across Canada with funding to build or improve critical infrastructure – such as drinking water, wastewater, stormwater and solid waste that will support the construction of new homes.

If successful in the grant application, up to 40% of all eligible costs would be covered.

#### Analysis:

This grant opportunity supports pairing with the HEWSF grant application to "stack" the grants and if successful in both opportunities would see up to 100% of eligible costs covered by grant funding. This project presents an estimated cost between \$13M and \$15M for infrastructure that will be required to accommodate future growth near Geeson Avenue. The project will also benefit the former Town of Walkerton as a whole. Staff are recommending application to this grant opportunity,
