4. Delegations

4.1 Walkerton Lawn Bowling Club - 2025 Budget Request

Richard Osborne, Head Greenskeeper and Property Maintenance and Don Clark, Maintenance Crew, provided an overview of the history of the Walkerton Lawn Bowling Club ("the Club") and some of the highlights from the previous year.

Mr. Osborne highlighted some features of the property and the reason for the capital requests being put forward by the Club.

Mr. Osborne responded to questions from Council about which project may be the highest need for the Club as the fencing and secondly the security lighting.

5. Reports

5.1 Walkerton Lawn Bowling 2025 Capital Request

Colleen Gillis, Director of Community Services and Brad Thomson, Facilities and Park Supervisor, responded to questions from Council about the number of grants that have been applied for on behalf of the Club.

Council discussed the number of items being proposed in the capital request and the importance of safety and security for the Club. Council proposed a smaller funding amount to begin addressing the repairs related to the fencing and lighting. Council debated the appropriate funding to ensure the fence was properly fixed noting that Brockton was the owner of the Property. Mr. Thomson explained the cost of \$14,000 to complete all the areas where the fencing required repair.

5.3 Walkerton Centennial Park Pool Floor Refinishing

Council discussed the priorities for Walkerton Centennial Park Pool, including the health and safety concerns for the pool flooring.

Colleen Gillis, Director of Community Services, described the state of the floors that had been completely repainted in the past year and degraded quickly.

Council discussed the potential use of the reserve fund for the epoxy floors. Trish Serratore, Chief Financial Officer, recommended using the working capital reserve fund.
