Report:

Background:

On December 5th 2024, staff received correspondence from Saugeen Valley Conservation Authority ('SVCA') regarding updating their Environmental Planning and Regulations Policies Manual with an initial timeline for comments returned by January 6th, 2025. With limited timeframe for the initial commenting period the commenting period has been extended to February 28th 2025. As recent as February 21st 2025 the SVCA hosted a stakeholders online meeting surrounding the draft update Policies Manual.

Analysis:

Even with the extended commenting period to February 28th 2025, Municipal staff have not had the opportunity to conduct in an in depth review of the updated draft SVCA Environmental Planning and Regulations Policies Manual. In depth review would be required to compare and analyze the existing policy with the draft policy and legislative changes.

Without the necessary time to complete an in depth review Municipal staff's overall comment and opinion remains that Environmental Planning and Regulations Policies should remain framed in a manner that outline the mandated roles and responsibilities of the SVCA and that such polices do not expanded into other areas that are beyond the scope jurisdictions for Conservation Authorities.

Municipal Staff are aware of comments being submitted by the Bruce County Planning Department as well as some comments being provided by other local Municipalities.

Municipal staff seek input from Council on any additional comments to be provided by the Municipality as a stakeholder on the draft SVCA Environmental Planning and Regulations Policies Manual.
