#### 6. Ongoing Business

#### 6.1 Update on Portable Toilet Quotes and Awarding of Contract

H. Pratt received the following quotes for portable toilets.

### Quote 1 - Scotty's Potty's - Chesley

Normal pricing for a standard unit is \$170/month (billed every 4 weeks) however two units booked for May- Sept, would be discounted charge of \$160/unit billed on a 28-day cycle. This would include weekly cleaning and stocking.

**Quote 2** - Bluewater Sanitation - Tiverton - <u>Current provider</u>
Unit pricing with weekly servicing \$170/month (28 days) per regular unit + \$20 delivery fee/unit.

#### Quote 3 - CP Portables - Teeswater

Basic Unit serviced weekly \$170/month, (Unit with hand sanitizer \$180/month), one-time fee of \$30 for delivery +HST.

#### Quote 4 - Wilton Sanitation - Flesherton

Pricing \$190/month (28-day cycle) less \$30 municipality fee, plus \$5 environmental disposal fee. One time charge \$25/unit for delivery/pickup +HST.

In past years the portable toilets have been booked from June 1 to the week after Thanksgiving.

Board members discussed what time frame the portable toilets should be delivered. It was decided, both portable toilets (Lions Park and Baseball diamond) to be delivered May 16th (Friday of Victoria Day weekend) to the

week after Thanksgiving, if the ball diamond is not rented, board members will have it picked up earlier. H. Pratt to confirm that the portable toilet at the ball diamond can be picked up earlier if not needed and find out if there is a delivery fee.

That the Elmwood Community Centre Board award the portable toilet contract to Scottys Pottys.
