5.1 Walkerton Homecoming 2026

Jeremy Wright and Mat Coleman, Co-Chairs of Walkerton Homecoming 2026 presented their business plan to Council. Mr. Wright and Mr. Coleman advised that a steering committee was formed to begin the planning process for the 2026 Homecoming which was planned for July 30 to August 2, 2026. Mr. Wright and Mr. Coleman clarified that Walkerton Homecoming 2026 was not looking to be a

sub-Committee of Council but would appreciate funding support to offset the costs associated with the event. The Walkerton Homecoming 2026 Committee was requesting \$40,000 in seed money, and assistance regarding facility usage in the form of an agreement. The Walkerton Homecoming 2026 Committee was also looking for the event to be declared a Municipally Significant Event. If Council was not amenable to granting seed money, the Committee would also appreciate a sponsorship.

Council remarked on the excitement surrounding the 155th Anniversary, especially as the 150th Anniversary was unfortunately cancelled due to the COVID-19 pandemic.

Mr. Wright responded to a question from Council surrounding the cost budgeted for the parade, which would be put towards entertainment and advertising/sponsorships.

Council thanked the Committee members for volunteering and noted the community benefit of homecoming events.

Councillor Travale declared as conflict of interest in relation to this matter due to his role with the Kinsmen Club of Walkerton.

Fiona Hamilton, Director of Legislative and Legal Services (Clerk) provided an update that the Kinsmen Club of Walkerton confirmed a donation of \$10,000 towards the Tot Lot park and would further offer labour and volunteer hours where needed.

Council expressed excitement regarding the initiative and continuing a relationship with the long-standing service club, who previously provided contributions towards the park.

Ms. Hamilton and Sonya Watson, Chief Administrative Officer responded to an inquiry from Council, advising on the process entered into with service clubs in the past regarding fundraising plans, although no formal agreements had been entered into surrounding the maintenance and/or ownership of municipal parks. It was noted that a park naming policy and agreements could be a consideration for the future.

Council also noted the annual maintenance completed by the Kinette Club of Walkerton in previous years.
