- 4.1 Walkerton Official Plan and Brockton Zoning By-Law Review Presentation

David Welwood, Project Manager and Alison Bucking, Planner with J.L. Richards & Associates Limited introduced themselves and provided a brief planning primer, an overview of the project, and a description of the staff involved in the project.

David Welwood described the land use planning regime in Ontario and the role of the Official Plan. Mr. Welwood explained the types of policy considerations contained in the Official Plan related to agricultural preservation, natural heritage features, housing affordability and other topics of widespread consideration.

Mr. Welwood explained that the zoning by-law was a legal document that applied throughout the Municipality of Brockton and contained regulations for the use of land such as permitted uses, building height, setback requirements, accessory structures, lot coverage etc. According to Mr. Welwood, the zoning by-law would be considered applicable law in Ontario while the Official Plan was a policy document.

It was noted that the goals of the project were to align with legislative and policy changes as well as the Bruce County Official Plan update, address local priorities, improve usability and interpretation, and provide a foundation for future growth.

The purpose of the zoning by-law was to implement the official plan and to make sure these documents conform with the upper level planning documents.

Alison Bucking reviewed the scope of the review for the Walkerton Official Plan and the zoning by-law update, including climate change and adaptation, housing needs, parkland, agriculture, employment lands, servicing, transportation, and natural heritage and hazards. Ms. Bucking noted that the provincial policy statements refined the definition of employment lands and where those uses should be permitted, along with servicing policies and active transportation regulations.

Dieter Weltz, Building and Planning Manager, confirmed that engagement letters had been sent to indigenous communities and would confirm an acknowledgement of receipt had been received.

Mr. Welwood responded to questions from Council about the types of issues that received strong public engagement, such as permitted uses in hazard areas, housing affordability, additional residential units, and short-term rentals.

Mr. Welwood responded to questions about the urban boundary expansion and any conflict with agricultural uses through the County of Bruce Official Plan, although the settlement expansion areas had not yet been fully approved.

Ms. Bucking responded to questions from Council about trends in restrictions related to maximum lot coverage.
