# 6.1 Phone Line Update

Currently, Starlink bill payment is being made on E. Falkiner's personal credit card and submitted to Patsy for reimbursement.

E. Falkiner now has name of contact at bank who can assist with securing an ECC credit card and will follow up shortly. P. Becker directed to hold payment for Eh-Tel balance owing until E. Falkiner contacts them.

Board members discussed current internet and phone providers and future service options, including Ooma.

Eh-Tel and Starlink are both running at the community centre and E. Falkiner will go over to disconnect Eh-Tel.

#### 6.2 HVAC

E. Falkiner advised of in-floor heating loop problems, as the pump is not working properly. Lang's replaced the expansion tank and has ordered a new pump. This could be the cause of the higher than usual hydro bill. E. Falkiner to investigate thermostats for the in-floor heating to maintain temperature remotely.

#### 6.3 Wireless Access Points

E. Falkiner advised the board members that complaints were received about Wi-Fi usage during Farmers' Week. He proposes replacement units upstairs, downstairs, and by the washrooms, as well as a second controller for usage and remote monitoring. TP Link Equipment pricing for controller and 3 access point units is approximately \$400.00. E. Falkiner advised this should be done now and shown in finances under "Maintenance". Management of band width and number of users will improve service.

H. Pratt addressed ongoing hygiene issue (bird droppings) on entry door key lockbox. Several suggestions were put forth and S. Lehman will look into solution.

M. Sugden advised, as per email from S. Travale, no applications were received for the ECCB Brockton community representative vacancy.

With the budgets being approved, B. Thomson advised E. Stangler that quotes will be needed as soon as possible for the Lions Park water drainage/grading issue as the companies start their work scheduling soon. E. Stangler has one quote and will contact other contractors for a second quote.
