That the Council of the Municipality of Brockton hereby receives Report Number PW2025-08 – 2025 Paving Tender, prepared by Nicholas Schnurr, Director of Operations and in doing so awards the contract to Walker Construction Limited in the amount of \$913,138.00, plus HST.

Report:

Background:

Concession 8 in the former township of Brant was identified in the 2025 municipal budget deliberations to need surface reconstruction from County Road 19 to Sideroad 30. Staff budgeted \$1,350,000 for the total project. Staff put together tender documentation and advertised the tender as per the Brockton Procurement Policy.

There were four (4) tender submissions as follows:

Walker Construction Limited	\$913,138.00
Cox Construction Limited	\$956,410.00
MacDonnell Excavating Ltd	\$1,253,000.00
E. C. King Contracting	\$1,283,360.00

Analysis:

Staff have reviewed all tender submissions for completeness and accuracy. Staff note the bids are very competitive, resulting from well prepared documents and a well-defined scope of work. The lowest tender bid is in line with what staff estimated and provides contingency, within the budgeted estimate for unforeseen construction circumstances. The budget also allows for in-house work to be completed after the paving, shouldering, signage, etc.

Staff are recommending awarding the contract to Walker Construction Limited in the amount of \$913,138.00 plus HST.


