That the Council of the Municipality of Brockton hereby approves Report Number CAO2025-06 – Housing Needs Assessment, prepared by Sonya Watson, Chief Administrative Officer and in so doing authorizes proceeding with J.L. Richards to complete the Housing Needs Assessment through previously received funding to support the Housing Accelerator Fund initiatives and in conjunction with the Official Plan/Zoning By-Law Review project.

Report:

Background:

As previously reported the Municipality of Brockton was successful in obtaining up to \$3.4 million in funding as part of The Housing Accelerator Fund ("HAF"). The goal of this program is to support lasting changes that will improve housing supply for years to come. A number of initiatives are being implemented as part of the approval with the intent of increasing housing supply in Brockton.

As part of the application requirements and an application to Bruce Power for funding Brockton was to initiate a Housing Needs Assessment. This document will look at demographics, review current housing types and identification of gaps in housing types with a future focused lens based on growth projections and available land. Previously Council approved the direct procurement of Monteith Brown Planning Consultants for this purpose.

Analysis:

Upon approval of the HAF funding and upon initiation of the Official Plan/Zoning By-Law project which was awarded to J.L Richards staff considered the merit in trying the two projects together to minimize costs. Community consultation efforts, planning policy, land review and demographics would all tie into the Official Plan and Zoning By-Law Review. In accordance with the Purchasing and Procurement Policy quotes have been obtained and within staff's approval limits we recommend proceeding with J.L Richards as the lowest quote to

complete the Housing Needs Assessment. This work will proceed immediately and in conjunction with the Official Plan/Zoning By-Law project. The Housing Needs assessment will provide valuable insight to developers looking to build in Brockton and support future grant applications and future focused work related to increasing housing supply.
